FX rate applicable to any amounts in this example is AS "SEB banka" commercial currency conversion rate on 2021-03-16 (1.192 US dollars for 1 EUR) and the real rate can differ. FX costs shown here are costs related to fees (or other costs), which are calculated in instrument denomination currency and deducted in EUR, or vice versa. Please bear in mind that the return may increase or decrease as a result of currency fluctuations.
